A. Recommendation from City Administrator:

Authorize the closing of the following streets on Sunday, December 1, 2024 for the Holiday Hustle 5K Race, Elf Fun Run and Holiday Light Parade:

1) Conant Street from Broadway to Anthony Wayne Trail from 4:00 pm until 8:00 pm;
