MINUTES  
Monday, January 6, 2025 at 6:15 pm

The Council of the City of Maumee, Ohio met on the above date in Council Chambers with the following members present: Gabriel Barrow, Jon Fiscus, Josh Harris, Ted Kurt, Philip Leinbach, Scott Noonan, and Margo Puffenberger (7). James MacDonald presiding.

COMMITTEE OF THE WHOLE

Mr. Leinbach made a motion to table Ordinance 001-2024 until the Municipal Planning Commission can address their concerns. The motion was lost due to an absence of a second.

Mr. Leinbach made a motion to move Consent item 9D to New Business 10A. Mr. Kurt seconded the motion. Roll call: 7 voting yea; the Chair declared the motion carried.

Mr. Leinbach made a motion to hold a public meeting with the Municipal Planning Commission prior to the second reading of Ordinance 001-2024. Mrs. Puffenberger seconded the motion. After discussion of the concerns, the motion was withdrawn.
